Old Business:

- SCC Registered Agent change completed on 6/19/23.

 eliminate excess debris in the Forebay area. Drafted notification to be put out to

 beside their property.
- In response to silt build up and lake maintenance, J.Parent contacted the Army Corp of Engineers and Virginia DEQ for guidance on addressing the silt issue with lake maintenance.
- The Board will issue a trespassing notification with the 2024 membership renewal readdressing expectations and detailing how to report an incident.

- R.Costanzo presented Fisheries Study proposal from EnviroScience for \$8,000.00.
- B.DeRusha, J.Parent, and T.Petty are working with Kinloch Property Owners Association and Kinloch Golf Course to outline Kinloch Lake Roles, Responsibilities, Authorities, and Accountabilities regarding the lake and lake properties as this will shape lake shore protection.

New Business:

- 2023 Kinloch Lake Association Budget was reviewed. B.DeRusha motioned to approve, J.Parent seconded, and all approved.
- R.Costanzo proposed holding off on doing a fish study in consideration of a study
 that reflects the water quality for the health of the fish. B.DeRusha suggested
 that Kinloch Golf Course be involved in any consideration as they control the flow
 and usage of the lake water. R.Costanzo also proposed bringing in speakers
 (even college students working on their doctorates) to address lake/fish health at
 the next Annual Meeting. Lake Health study was tabled until the spring.
- Insurance Policy Renewal was reviewed and approved. T.Petty will submit approval.
